If smoking is banned in all eating places, we will not suffer from passive smoking easily. The environment will be better and the air will be fresher. It is good for both workers and customers in eating places. I am sure that public health will improve greatly if such a new policy is implemented.

For the government, banning smoking in all eating places is a worthwhile practice. Every year, the amount of money spent on medial care for patients with diseases caused by smoking is enormous. According to a research conducted by the University of Hong Kong, the estimate for expenses on health care in connection with smoking-related diseases is \$1.9 billions. Smoking costs Hong Kong over \$5 billion every year. If smoking is banned in eating places, it will discourage people from smoking. Thus, public health can be improved and less expense will be incurred on treating diseases caused by smoking. More importantly, the money saved can be invested into many other meaningful projects, like medical research or recreational facilities for teenagers.

For the owners of eating places, banning smoking will reduce their business because there are a huge number of smokers going to the eating places.
