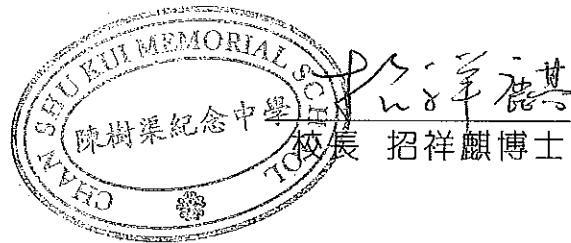

Briefing Session for Parents of New NCS Students

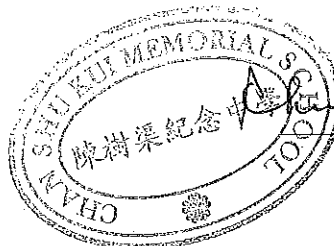
